Public comment

- Stephen Whitaker requested that CVFiber's executive session be recorded in the event that a judge needs to review whether the executive session strayed into areas that were not eligible under statute for executive session.
- Stephen Whitaker noted that under open meeting law, members of the body need to identify themselves. Allen Gilbert responded that we are identified by our name labels on the zoom call.

Discussions with NEK Broadband Executive Committee

- Christa Shute provided an update on the status of the bill allowing for merger of CUDs (S199). The bill has passed through the Senate Finance Committee and House and Energy and has been moved to the floor for its second reading.
- Stephen Whitaker read from open meeting law and objected to CVFiber's Executive
 Committee entering executive session on the grounds that he believes CVFiber does not
 have a valid meeting. Siobhan Perricone recognized Stephen's objection and reiterated
 that everyone who is a member of the Executive Committee has name labels that are
 visible in the meeting recording.
- MOTION (Jeremy Matt, Second Allen Gilbert)

 Move that we find that holding a discussion of strategic planning and potential coordination with NEK Broadband would put CVFiber at a substantial competitive disadvantage in accordance with 1 V.S.A. § 313(a)(1).
- Siobhan Perricone turned control of the floor over to NEK Broadband. NEK Broadband moved to enter executive session.
- MOTION (Jeremy Matt, Second Allen Gilbert)
 - Whereas the Executive Committee has found that discussion of strategic planning and potential coordination with NEK Broadband in open session would put CVFiber at a substantial competitive disadvantage,

Move that we enter executive session to consider strategic planning and that CVFiber Board members, alternates, executive director, and treasurer, Mike Reed and the members and staff of NEK Broadband who are present are invited into the executive session as they have information that is needed in accordance with 1 V.S.A. § 313(b).
