Pricing Policies

Discussion Summary: Tonya introduced three proposed policies having to do with Seasonal, Installation Fees, and Cancellations. These policies have to be finalized by Oct. 10 which is the deadline for rolling out our broadband "nutritional" labels.

Proposed Seasonal Policy: the proposed policy is to have an upfront charge of \$150 to reconnect your service after you pause it as long as you give a date that you want service (and automatic billing) to start up again. If you bundle phone with your internet, you would pay an upfront fee to keep a hold on your phone number. There was discussion around proposing 9 months as the longest time you could pause your service.

Proposed One time Installation Fee of \$99: (CVFiber had a \$99 install fee, but this fee was never charged to any customers), which would cover the first 500 ft of fiber for aerial or construction. Additional feet of fiber would be \$1.75/ft. The CrowdFiber process would have a question about whether the fee would cause a hardship. If the customer answers "yes" then there would be a process to verify their income through partner organizations like NEKCA. Money received from the fee could help cover hardship waivers and long drops. Along with the installation fee would be a system for full-time customer appreciation checks - \$25 after the first two years (24 consecutive months - not seasonal folks), \$50 after the first 5 years and \$100 after the first 10 years. This would be done for all customers, whether they paid for installation or not. BEAD requirements allow for a "reasonable" installation fee, and all of this may have to change if we get BEAD funding.

Proposed Cancellation Policy: a \$300 reconnect fee would be charged if someone wanted to renew service within 24 months. \$300 is only part of the \$2000 cost per address of installing service.
