### **BEAD Funding Update**

**Discussion Summary:** Christa said that the BEAD application portal is open and that full applications are due on April 16. She said that the following motion demonstrates the Governing Board's support for the project to get fiber optic service to every unserved address in the District, which is over 8,000 addresses - half of the unserved addresses in the entire state. The motion also provides authorization for Christa and Chris to take the necessary actions to submit a full application. Christa noted that the current direction of the BEAD funding opportunity review by the federal Commerce Department seems to be to amend and not end it. There was some discussion about whether the motion should remove the specifics about the regions so the motion would reflect a more unified "single organization" image, but the consensus seemed to be this was not a deal-killer. **Discussion Summary:** Christa highlighted for everyone two of the decisions that the Executive Committee made since the last Governing Board meeting. The first was the decision to change our engineering and construction manager from NRTC to CNE. The second decision was to allow us to enter into a loan commitment with Community National Bank for our letter of credit for RDOF in the amount of \$1,432,770.84 that will be backed by cash collateral. That cash collateral will come with the closing of the arrangement with CCI. The FCC has approved the transfer of the CCI RDOF areas to us. We are just waiting for the Public Utilities Commission to approve our Eligible Telecommunications Carrier application so that we can engage in the closing process and start bringing service to all of those RDOF areas.

#### Addendum to the BEAD Funding Update

**Discussion Summary:** Christa added that there are activities going on at the federal level primarily around exploring a tech-neutral approach to support lowest cost options and reviewing regulations that were put in place by the previous administration. She invited anyone to stay after the end of the meeting to talk in more detail.

Tonya then announced that we are requesting that Governing Board members draw up letters of support (using the sample letter provided as needed) for our BEAD funding application and work with their Select Boards to get them on town letterhead. This is in response to the application that is requiring "evidence of a written commitment to the project from all towns in the Final Project Area." We hope to have those letters back by Friday, March 28. Letters must be received before April 14 in order to be helpful and included in the application.

#### **Town Meeting Day Roundtable - Report Out from Towns**

**Discussion Summary:** Tonya thanked the two Map Ambassadors, Brian Machesney and John Reid for processing 33 maps and address lists for Governing Board members to use with their outreach efforts during Town Meeting Day. Kitty said that 53 out of 71 towns had some kind of outreach happening, from information on a table, to verbal presentations, to speaking one-on-one with folks, to the staffing of information tables. Brief report outs were then given by David Healy (Calais), Dana Caspersen (Kirby), Neil Glassman (Barnet), Mary Metcalf (Greensboro), Martin Klein (Groton), Donna Dzugas-Smith (Westmore), Mike Barrett (Waterford), Sonya Curtis (Irasburg), and Siobhan Perricone (Orange).
